Tuition Assistance 2016-2017

Applications for tuition assistance must be made on an annual basis. No family is guaranteed tuition assistance including those who receive GOAL funds, without an updated application that includes the first two pages of the most recent federal income tax filing (Form 1040). All applications, with the required tax filing information, must be received by **April 15, 2016**, for any tuition assistance to be considered. Applications can be started any time after March 1, 2016, as awards will be made on an as needed basis for as long as funds are available.

All families who receive any tuition assistance must be enrolled in automatic bank drafts (form attached below) for the account management. Tuition assistance will only be awarded when accounts are current.

If you anticipate a need for tuition assistance for the 2016-2017 school year, please complete the application, attach the first two pages of the most recent income tax return, and submit to the attention of Mrs. Holly Collins, Director of Finance, either by mail, email (holly.collins@tattnall.org), or FAX (478) 474-7887. Documents that are dropped off in the Business Office should be secured in a sealed envelope with the applicants name written on the front.
